Some Restrictions Apply:

- Ductless mini-split cooling-only units are not eligible.
- Must be purchased and installed between 1/1/25 and 12/31/25.
- Applications must be postmarked by 1/31/26 and sent to the address above.
- Rebate less than \$1,000 will be applied as a bill credit on your electric bill.
- **Heat pumps must be installed by a licensed contractor. No self installs.**

- Air Source Heat Pump**
\$500 per Ton/12,000 BTUs of Cooling Capacity
 - Heat Pump Must Have a SEER2 ≥ 15.2 and HSPF2 ≥ 8.1
- Ground Source Heat Pump**
\$750 per Ton/12,000 BTUs of Cooling Capacity
 - Heat Pump Must Have a EER2 ≥ 19.2 and COP ≥ 3.5

Maximum rebate amount is 36,000 BTUs per address, per calendar year

Note: Exact rebate dollar amount is calculated using the Cooling Capacity BTUs listed on the AHRI Certificate
